The proposal is to remove existing wood fence and install 2,255 lineal feet of white Echelon Majestic 3-rail flat top 6' wide by 54 inches high ornamental aluminum fencing. Existing fence posts will be cut at ground level and hauled away.

The product will be installed to manufacturing specifications. Terms of payment would be 50% down and the net on completion.

Total cost would be \$45,992.00.

The board strongly recommends this solution to our recurring fence repair expense and guarantees an up-to-date atmosphere to the subdivision for years to come."
